2. A detailed description must be provided on how the requirements specified in this document match the capability, experience, knowledge and expertise of the Company
3. The Application must be submitted in the English language. All required information must be provided, responding clearly and concisely to all the points set out. Any application which does not fully and comprehensively address this Request for Expression of Interest may be rejected.
4. The Application document should comprise of the following:
 - a. Cover Letter;
 - b. A copy of this Request for Expression of Interest duly signed on all pages by the Company/Service Provider's Authorized Representative; and
 - c. Duly Accomplished Annex A with All requested information.

Only eligible and qualified Companies based on above shall be invited to participate in the future bidding/tender process.
