IOM now invites Eligible Service Providers to submit Technical and Financial Proposal for the following Services: Lease of Vehicles (Passenger vehicles and Cargo Trucks) for IOM Operations in Afghanistan on a Long-Term Basis (2022-2023) (One Year with possible extension for another year). More details on the Services are provided in the Terms of Reference (TOR).

This RFP has two lots, first lot is for provision of passenger transportation services for IOM operation in Afghanistan and second Lot is for provision of cargo transportation services for IOM operation in Afghanistan

The Service Provider will be selected under a Quality – Cost Based Selection procedures described in this RFP.

*(Please provide with a bank statement/financial statements/Audited
Financial Statements for one of the last 3 years)*

A pre-bidding conference will be held on 02 Feb 2022 at 2:00pm hours at IOM Office in Kabul. Attendance to the conference is optional.

In order for your company representative to be allowed to the pre-bid meeting please send us name and NID (Tazkira) Number or Passport Number of your representative by at least **29th January 2022 before 3:00 PM**. No one will be allowed to the pre-bid meeting without prior introduction.

The Proposals must be delivered by hand or through courier to the IOM with office address at House # 28, Street # 3, Ansari Square, Shahr-e-Naw, (Opposite to German Clinic), Kabul, Afghanistan on or before 06 February 2022 at 4:00pm hours. No late Proposal shall be accepted.

IOM reserves the right to award both lots of the contract to one or two service providers or accept or reject any Proposal and to annul the selection process and reject all Proposals at any time prior to contract award, without thereby incurring any liability to affected Service Providers.
